4. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in.
5. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
6. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

8. It will continue to pay Annual Fee of Rs.3000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee in CBSE by D.D./Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet Vihar, Delhi-110092
